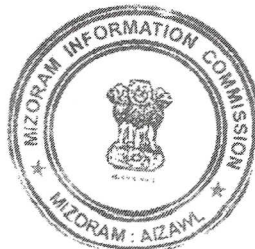

DECISION

(08.03.2011)

The Mizoram State Information Commission has received **Second Appeal** under Section 19(3) of the RTI Act, 2005 from Pu Paritosh Chakma, Janakpuri, New Delhi. The Appellant complaint that he sought the information to the Respondent on 12.08.2010 as to intimate :- (i) whether any complaint was received against Mrs Swapna Chakma, who was dismissed from SSA Teacher posted in Silsury Village Mamit District and whether the complaints have been investigated; (ii) Copy of the report submitted, if any, by the Mamit District Project Coordinator, SSA in relation to her case.

But the SPIO failed to submit information sought by the Appellant within a stipulated period of 30 (thirty) days under the RTI Act, 2005. As stated by the Appellant, the First Appeal was preferred to the Departmental Appellate Authority on 23.11.2010 via speed post which was delivered on 06.12.2010 as recorded by the Postal Department but no response was received within a stipulated period of time. As the required information were not given to the applicant, the Appellant filed the Second Appeal to the State Information Commission to get the required documents. The SPIO, District Project Coordinator, Office of the State Project Director, SSA Aizawl Mizoram was summoned to appear before the Commission to present the case and justify his position with connected papers on 03.03.2011.

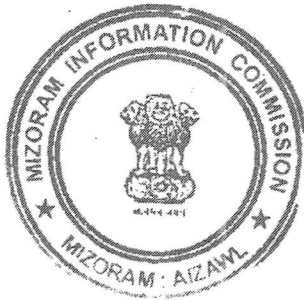

The SPIO, Shri V.Lalsiamthara appeared in person before the Commission on 03.03.2011 and heard. From the record maintained by the SPIO concerned, it is clear that appropriate action had been taken on the application within the time limit. On further scrutiny, it was observed that the address of the Appellant printed in the reply paper was incomplete, hence it is very clear that the letter will not reach to the desired destination. The SPIO is, therefore instructed to send another copy of the same reply to the Appellant indicating complete address within 7(seven) days with a copy to this Commission.

Action Taken Report of SPIO, Mizoram SSA Mission Aizawl has been received by this Commission on 08.03.2011

The Case is, therefore closed accordingly.


