**TERMS AND CONDITIONS:-**

1. The bike can be inspected by the interested persons during office working hours in the presence of Pool Officer or her representatives in Mizoram Information Commission, Aizawl.
2. The Quotation should be in Sealed with wax superscribed as ‘**QUOTATION FOR CONDEMNED BIKE**’.
3. The quotation should be submitted with **₹ 150/-** (Rupees one hundred fifty) only as earnest money in the form of ‘Deposit at Call’ from any Scheduled Bank in favour of Secretary, Mizoram Information Commission, Aizawl.
4. Quotation without Earnest money will be summarily rejected.
5. The quotationer should quote his/her rates both in figure and in words, and any corrections, overwriting, cutting must be initialed with date, failing which the quotation will be treated as invalid.
6. The quotationer should indicate his/her telephone/mobile number or nearest contact number.

7. The quotationer or his/her representatives can be present at the time of opening the quotations/tenders if he/she so desires. No complaint will be entertained if the quotationer or his/her representative is not present at the time of opening.
8. Release order of the auctioned bike to the successful bidder will be issued only after receipt of Treasury Challan deposited under the Head of Account : 0077-OAS, 60-OS, 800-Other Receipt.
9. As proof of the bid amount, the allottee shall lift the allotted bike within three (3) days from the date of issue of release order. In case of failure to do so, this Office will not be responsible for safe custody and the allottee will have to pay ₹.50/- per day as additional garage rent from the date of expiry of the prescribed time.
10. The earnest money(Call Deposit Amount) will stand forfeited in favour of the Government if the successful bidder refuses or fails to lift the bike within ten(10) days from the date of issue of release order.
11. The bid amount (money) shall be deposited within seven days from the date of issue release order. In case of failure to deposit the bid amount within the prescribed period by the highest bidder, the allotment will be treated as invalid and offer will be made to the second highest bidder and so on
