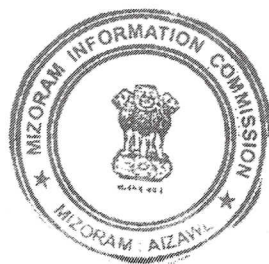

ORDER
(02.03.2011)

The Mizoram State Information Commission has received **Second Appeal** under Section 19(3) of the RTI Act, 2005 from Pu Paritosh Chakma, Janakpuri, New Delhi. The Appellant complaint that he sought the information to the Respondent No.1 on 01.10.2010 to provide :- (i) A copy of appointment order of Pu Zothansanga s/o Laibuana, who was appointed as SSA Teacher at Uguduasury Primary School; and (ii) A copy of Performance Reports of Pu Zothansanga submitted by the Village Education Committee of Silsury. But, the SPIO failed to submit any information sought by the Appellant within a stipulated period of 30 (thirty) days under the RTI Act, 2005. As stated by the Appellant, the First Appeal was preferred to the Departmental Appellate Authority on 23.11.2010 via speed post which was delivered on 03.12.2010 as recorded by the Postal Department but no response was received within a stipulated period of time from the Respondent No.2 also. As the required information were not given to the applicant, the Appellant filed the Second Appeal to the State Information Commission to get the required documents. The SPIO, District Project Coordinator, SSA Mamit District was summoned to appear before the Commission to present the case and justify his position with connected papers on 23.02.2011.

The SAPIO, SSA Mamit District Pu PC Lalthianghlina appeared in person before the Commission on 23.02.2011 and heard. He had explained that the required information was already sent to the Appellant by the State Project Director, Directorate of School Education on 19.10.2010 with a copy to the PS to the Hon'ble Minister, School Education, etc and the Secretary, Education & Human Resources Department, Govt.of Mizoram.



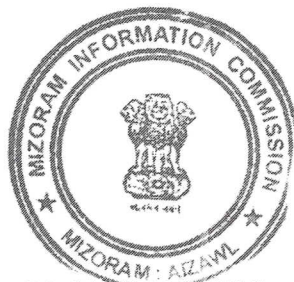

On scrutiny, it appears that there was wrong information about the place of posting of Pu Zothansanga, SSA Teacher. His original place of posting was Luimawi from where he was transferred to Uguduasury Primary School. But before reporting to his new place of posting, he was temporarily transferred and asked to report himself at Kanhmun Primary School No.I instead of Uguduasury Primary School.

The SAPIO, Office of the District Project Coordinator, SSA Mission Mamit is directed to clarify the position to the Appellant with a clear explanation regarding Performance Report of Pu Zothansanga submitted by VEC Silsury and also to supply copy of original reply sent by the State Project Director, Mizoram SSA Mission within 7 (seven) days from the date of Hearing with a copy to this Commission.

Action Taken Report of SAPIO, SSA Mission Mamit has been received by this Commission on 25.02.2011 and the required information were sent to the Appellant with connected documents and also submit clear explanation of the case on 24.02.2011.


The appeal is, therefore disposed accordingly.
