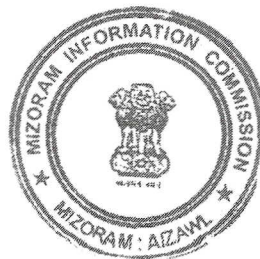

**DECISION**  
(17.03.2011)

The Mizoram State Information Commission has received **Second Appeal** under Section 19(3) of the RTI Act, 2005 from Pu Paritosh Chakma, Janakpuri, New Delhi. The Appellant complaint that he sought the information from the Respondent on 12.07.2010 to provide the Year-Wise amount of Flood Relief released by the Government of Mizoram to Silsury Village in Mamit District during 2000 – 2010 and List of Beneficiaries.

But the Respondent failed to submit information sought by the Appellant within a stipulated period of 30 (thirty) days under the RTI Act, 2005. As stated by the Appellant, the First Appeal was preferred to the Departmental Appellate Authority on 23.11.2010 via speed post which was delivered on 03.12.2010 as recorded by the Postal Department but no response was received within a stipulated period of time. As the required information were not given to the applicant, the Appellant filed the Second Appeal to the State Information Commission to get the required documents. The SPIO/SDO(Sadar), Office of the Deputy Commissioner, Mamit District Mizoram was summoned to appear before the Commission to present the case and justify his position with connected papers on 24.02.2011(Thursday) at 11.30 A.M.

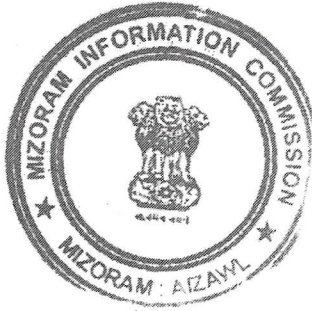

The SPIO, Shri VL Remlalliana, SDO(Sadar) appeared in person before the Commission on 24.02.2011 and heard. He had informed the Commission that the original application was not received by them. However, the Respondent came with full information about the requested documents. He has been instructed to send the reply to the Appellant directly explaining reason for delaying the Answer with a copy to this Commission within 7(seven)days.

The SPIO has now been complied with the instruction and copy of the reply was endorsed to this Commission.
